We are pleased to provide this update for Arena REIT's (ARF) activities for the guarter ended 30 September 2015 and enclose a copy of your distribution statement for the period.

Quarterly distribution of 2.675 cents per security

ARF has paid a distribution of 2.675 cents per ARF stapled security for the guarter ended 30 September 2015. This is in line with our distribution guidance of a total of 10.71 cents per security for the year ending 30 June 2016, which represents an increase of 7% on the previous year.

Approximately 30% of securities on issue participated in the DRP at an issue price of \$1.5974 per security, based on the average daily volume weighted average price (VWAP) over the period 2 to 22 October 2015, less a pricing discount of 1.5%.

Strong financial results for FY15

On 25 August 2015, ARF released its financial results for the year ended 30 June 2015 (FY15). It was another successful and active year, delivering solid results. Reported statutory profit for the year was \$61m (up 37% on the prior year) derived from a combination of revaluation gains (\$42m) and increased operating earnings of \$22m (up 15% on the prior year). Earnings per stapled security increased by 15% from the prior year to 10.2 cents and net asset value grew by 18% over the year to \$1.33 per stapled security. Over FY15 ARF also outperformed the benchmark ASX 300 A-REIT Accumulation Index by 16.1%, returning 36.3%.
