#### **Dear Investor**

We are pleased to provide this update on Arena REIT (Arena) for the quarter ended 30 September 2022 and enclose a copy of your distribution statement for the period.

## QUARTERLY DISTRIBUTION OF 4.20 CENTS PER SECURITY

Arena has paid a distribution of 4.20 cents per stapled security for the quarter ended 30 September 2022; today's distribution is in line with FY23 distribution guidance of 16.8 cents per security announced to the ASX on 11 August 2022, which represents an increase of 5% on the prior year annual distribution.

Approximately 22% of securities on issue participated in the Dividend and Distribution Reinvestment Plan (DRP) for the period. The DRP issue price of \$3.4420 per security was calculated based on the average daily volume weighted average price over the period 4 to 17 October, less a discount of 1.5%.
